UGC REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTE, 2009

(Under Section 26 (1) (g) of the University Grants Commission Act, 1956)

Ragging is totally prohibited in Delhi Technological University. The following acts constitute ragging.

1. Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
2. Indulging in rowdy or undisciplined activities by any student or students which cause or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
3. Asking any student to do any act which such student will not in the ordinary course do and which as the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche with any fresher or any other student;
4. Any act of a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher;
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
7. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
8. Any act or abuse by spoken words, emails, post, public insults which would also include deriving prevented pleasure, vicarious or sadistic thrill for actively or passively participating in the discomfiture to fresher or any other student;
9. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure of showing off power, authority or superiority by a student over any fresher or any other student.

Administrative action in the event of ragging

The university shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under :

- a. The Anti-Ragging Committee of the university shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.
- b. The Anti-Ragging Committee may, depending on the nature of gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, may be initiated namely;

- i. Suspension from attending classes and academic privileges.
- ii. Withholding / withdrawing scholarship / fellowship and other benefits.
- iii. Debarring from appearing in any test / examination or other evaluation process.
- iv. Withholding results.
- v. Debarring from representing the university in any regional, national or international meet, tournament, youth festival, etc.
- vi. Suspension / expulsion from the hostel.
- vii. Cancellation of admission
- viii. Rustication from the university for period ranging from one to four semesters.
- ix. Expulsion from the university and consequent debarring from admission to any other university for a specified period.

Provided that where the persons committing or abetting the act of ragging are not identified, the university shall resort to collective punishment.

SIR C. V. RAMAN
(1888-1970)

Sir Chandrasekhara Venkata Raman was one of the greatest physicist the world has ever seen. He was born to Chandrasekhara Ayyar, a scholar in Physics and Mathematics, and Parvathi Ammal, on 7th November 1888, Tiruchirapalli, a town on the banks of the river Cauvery.

Raman was a child genius and stood first in every class. He joined the B.A. class of the Presidency College. He published his first scientific paper at the age of 17 in The Philosophical Magazine in London. He did his M.A. from the same institution. He possessed the power of concentration and intelligence, and an insatiable curiosity to learn new things. He used to read more than what was taught in the class.

In 1921, Raman attended the British Empire Universities' Congress in Oxford, England. He questioned the very idea that the water's blue color was due only to the reflection of the sky. He later proved that the deep blue color of the sea is due to the scattering of light by the water. His many investigations on light scattering culminated in his discovery of the Raman Effect in 1928, for which he received the Nobel Prize two years later, in 1930.

Sir C. V. Raman was honoured with a large number of honorary doctorates and memberships of scientific societies and was elected a Fellow of the Royal Society early in his career (1924), and was knighted in 1929. This great physicist died on November 21, 1970 in Bangalore, India.

SIR J. C. BOSE **(1858 - 1937)**

Sir Jagadish Chandra Bose, remembered for his invaluable contributions to the scientific world was born on the 30th of November 1858 in Faridpur in Dacca District. His mother, Abala Bose was a tenderhearted and affectionate woman, and his father, Bhagawanchandra Bose, the Deputy Magistrate of Faridpur, was a man of excellent qualities.

Right from his school days, Jagadish Chandra was most interested in Biology (the science of life). But Father Lafont, a famous Professor of Physics, inspired in Bose a great interest in the science of Physics and Bose became his favourite student. Botany, the science of plants, still attracted him much. J.C. Bose went to England for studying medicine and then Natural Science in Christ Church College, Cambridge. He passed the Tripos Examination with distinction and the Bachelor of Science Examination of London University. He was the first professionally trained mainstream Indian scientist to be elected a fellow of the prestigious Royal Society of London.

He had invented many useful instruments, for example he developed an instrument that showed the reaction of an organism when excited by electricity on a graph. He proved through experiments that when outside stimulus is applied to plants, they respond to it.

P. C. Ray reminded the audience assembled in 1916 to greet Bose on his knighthood, that “If he had taken out patents for the apparatus and instruments which he had invented, he could have made millions by their sale”. This great scientist passed away in 1937.

SIR M. VISVESVARAYA **(1861 - 1962)**

One of the eminent engineers of our land, Sir M. Visvesvaraya, was born in Muddenahalli in the Chikkaballapur Taluk of Kolar District (Mysore State), on the 15th of September 1861. His father Srinivasa Sastry was himself a scholar in Sanskrit.

Visvesvaraya completed his early education in Chikkaballapur; then he came to Bangalore for higher education. He joined the Central College. He joined the Science College in Poona to study Engineering. In 1883 he ranked first in the L.C.E. and the F.C.E. Examinations.

Soon he was appointed as an Assistant Engineer in Nasik, where he implemented a new system of irrigation called “Block System”, for supplying water from the river Sindhu to a town called Sukkur. He was soon promoted and was the Chief Engineer of Mysore for 3 years before being chosen by the Maharaja as his Dewan in 1912.


In 1918 Sri M Visvesvaraya retired voluntarily and went on to fulfill his dream by starting an Automobiles Factory and an Aircraft Factory in Mysore State. The Hindustan Aircraft Factory (now called the Hindustan Aeronautics) in Bangalore, and the Premier Automobile Factory in Bombay owe much to his efforts.

Visvesvaraya later published two books, ‘Reconstructing India’ and ‘Planned Economy for India’. Even at the age of 98 Visvesvaraya was writing books on planning. L. S. Sheshagiri Rao wrote: “One of the makers of modern India. ‘MV’ was a genius. Perfectly honest and devoted to his work, he set new standards of efficiency”. Service of the country was this great man’s ‘tapas’. The Government of India brought out a stamp in his honor. This great son of our land passed away on 14th of April 1962.

VARAHAMIHIRA **(BC 587 - BC 505)**

The famous astronomer Varahamihira, a contemporary of Vikramaditya and Kalidas, had been the author of Brihat-Samhita. Possibly he was a resident of Ujjain. He too is counted among the nine jewels of the court of Vikramaditya. From his non-acquaintance with the theory of Earth revolving round the Sun, as propounded by Arya Bhatt, it appears clearly that he must have been belonging to an earlier period.

Varahamihira also called Varaha, or Mihira (B.C. 505, Ujjain, India--B.C. 587, Ujjain), was Indian philosopher, astronomer, and mathematician, author of the Pañca-siddhantika ("Five Treatises"), a compendium of Greek, Egyptian, Roman, and Indian astronomy. Varahamihira's knowledge of Western astronomy was thorough. In five sections, his monumental work progresses through native Indian astronomy and culminates in two treatises on Western astronomy, showing calculations based on Greek and Alexandrian reckoning and even giving complete Ptolemaic mathematical charts and tables. Although Varahamihira's writings give a comprehensive picture of 6th-century India, his real interest lay in astronomy and astrology. He repeatedly emphasized the importance of astrology and wrote many treatises on shakuna (augury) as well as the Brihat-Jataka ("Great Birth") and the Laghu-Jataka ("Short Birth"), two well-known works on the casting of horoscopes.

While Brihat-Samhita is largely devoted to astrology, it is a valuable source for history of Indian iconography. This mortal world is forever indebted to Varahamihira for his in fields as diverse as Philosophy, Astronomy and Mathematics.

BHASKARACHARYA

(1114 - 1184)

In many ways Bhaskaracharya represents the peak of mathematical knowledge in the Kaliyuga's 43rd century (i.e. 12th century A.D). Bhaskara, also known as Bhaskaracharya, meaning "Bhaskara, the teacher", was born in A.D. 1114 in Vijayapura. Bhaskaracharya's father was a Brahman named Mahesvara, who was himself a famed astrologer.

This great mathematician and astrologer reached an understanding of the number Systems and solving equations, which was not to be achieved in Europe for several centuries. He had propounded The Law of Gravitation, in clear terms, 500 years before it was rediscovered by Newton.

Bhaskaracharya became head of the astronomical observatory at Ujjain, the leading mathematical centre in India at that time. Outstanding mathematicians such as Barahamihira and Brahmagupta had worked there and built up a strong school of mathematical astronomy. He remained in Ujjain until his death in A.D. 1185.

Six works by Bhaskaracharya are known which are: Lilavati (The Beautiful) which is on mathematics; Bijaganita (Seed Counting or Root Extraction) which is on algebra; the Siddhantasiromani which is in two parts, the first on mathematical astronomy with the second part on the sphere; the Vasanabhasya of Mitaksara which is Bhaskaracharya's own commentary on the Siddhantasiromani ; the Karanakutuhala (Calculation of Astronomical Wonders) or Brahmatulya which is a simplified version of the Siddhantasiromani ; and the Vivarana which is a commentary on the Shishyadhividdhidatantra of Lalla.

In 1207 an educational institution was set up to study Bhaskaracharya's works. A medieval inscription in an Indian temple reads:-

"Triumphant is the illustrious Bhaskaracharya whose feats are revered by both the wise and the learned. A poet endowed with fame and religious merit, He is like the crest on a peacock..."

Bhaskaracharya hostel was inaugurated in the 2000.

SISTER NIVEDITA

(1867 - 1911)

Sister Nivedita was a dynamic philosopher whose life was a saga of service and sacrifice. She was born on October 28, 1867. Known as Margaret Nobel in her younger days, she was highly influenced by the teachings of Swami Vivekananda and came from distant Ireland to India to serve the people of this land. She was given the name “Nivedita” as one dedicated to God. She completely identified herself with the people and served the nation in various ways, in teaching, social reform, nationalism, relief work, journalism, art and architecture. In March 1899, when a devastating plague broke out in Calcutta, Nivedita formed a committee of social workers and literally saved hundreds of victims from the jaws of death, staking her own life in the process. She was a great intellectual and moral force behind the great Swadeshi Movement which came in the wake of the Partition of Bengal in 1905.

Sister Nivedita was an ardent patriot and a Karma-yogi of the Vivekananda brand. She was indeed a nationalist of nationalists. Her breadth of outlook, curiosity, courage, self-discipline and enthusiasm were without a parallel. She was looked upon as a luminous elder, leader and pioneer. Rabindranath Tagore called her ‘Mother of the people’. He once said: “She is to be honored not because she was like us, but because she was greater than we...”

KALPANA CHAWLA

(1961 - 2003)

Dr. Kalpana Chawla, born in Karnal, Haryana, India. Kalpana in Hindi means “imagination”. Her interest in flying was inspired by the India’s leading industrialists, J.R.D. Tata himself, a pioneering Indian pilot. She met and married Jean-Pierre Harrison, a flying instructor and aviation writer, in 1983 and became a naturalized United States citizen in 1990.

Kalpana earned her B.E. degree in aeronautical engineering at Punjab Engineering College Chandigarh (1982) and moved to the United States in 1982 and obtained a M.S. degree in aerospace engineering from the University of Texas at Arlington (1984). Kalpana went on to earn a second M.S. degree in 1986 and a Ph.D. degree in aerospace engineering in 1988 from the University of Colorado at Boulder.

Later that year she began working for NASA Ames Research Center as Vice President of Oversight Methods, Inc. where she did CFD research on V/STOL. She held a Certificated Flight Instructor rating for airplanes, gliders and Commercial Pilot licenses for single and multiengine airplanes, seaplanes and gliders.

She joined the NASA astronaut corps in March 1995 and was selected for her first flight in 1998. Her first space mission began on November 19, 1997 as part of the six astronaut crew that flew the Space Shuttle Columbia flight STS-87. She was the first Indian-born woman and the second person of Indian origin to fly in space. During STS-87, she was responsible for deploying the Spartan Satellite which malfunctioned, necessitating a spacewalk by Winston Scott and Takao Doi to capture the satellite.

The Space Shuttle Columbia met with a fatal accident on its return path while entering the earth atmosphere on February 1, 2003.

Dr. Kalpana Chawla shall continue to inspire engineering aspirants around the world for her exemplary courage, extraordinary capabilities and her love for space explorations.

HOMI JEHANGIR BHABHA


(1909 - 1966)

Homi Jehangir Bhabha was an Indian nuclear physicist who had a major role in the development of the Indian atomic energy program and is considered to be the father of India's nuclear program. Bhabha was born into a prominent family, through which he was related to Dinshaw Maneckji Petit, Muhammad Ali Jinnah, homi K Bhabha and Dorab Tata. After receiving his early education at Bombay schools and at the Royal Institute of Science, he attended Caius College of Cambridge University to pursue studies in mechanical engineering. After taking the mechanical engineering Tripos, he pursued studies under Paul Dirac to complete the Mathematics Tripos. Meanwhile, he worked at the Cavendish Laboratory while working towards his doctorate in theoretical physics under R. H. Fowler. During this time, he embarked on groundbreaking research into the absorption of cosmic rays and electron shower production. Afterwards, he published a string of widely-accepted papers on his theories regarding cosmic ray showers.

World War II broke out in September 1939 while Bhabha was vacating in India. He chose to remain in India until the war ended. In the meantime, he accepted a position at the Indian Institute of Science in Bangalore, headed by Nobel laureate C. V. Raman. He established the Cosmic Ray Research Unit at the institute, and began to work on the theory of the movement of point particles. In 1945, he established the Tata Institute of Fundamental Research in Bombay, and the Atomic Energy Commission of India three years later. In the 1950s, Bhabha represented India in International Atomic Energy Forums, and served as President of the United Nations Conference on the Peaceful Uses of Atomic Energy in Geneva, Switzerland in 1955. He later served as the member of the Indian Cabinet's Scientific Advisory Committee and set up the India National Committee for Space Research with Vikram Sarabhai. In January 1966, Bhabha died in a plane crash near Mont Blanc, while heading to Vienna, Austria to attend a meeting of the International Atomic Energy Agency's Scientific Advisory Committee.

SRINIVASA RAMANUJAN IYENGAR **(1887 - 1920)**


Srinivasa Ramanujan was an Indian mathematician who, with almost no formal training in pure mathematics, made substantial contributions to mathematical analysis, number theory, infinite series and continued fractions.

Born and raised in Erode, Tamil Nadu, India, Ramanujan first encountered formal mathematics at age 10. He demonstrated a natural ability, and was given books on advanced trigonometry by S. L. Loney. He had mastered them by age 13, and even discovered theorems of his own. He demonstrated unusual mathematical skills at school, winning accolades and awards. By 17, Ramanujan conducted his own mathematical research on Bernoulli numbers and the Euler-Mascheroni constant. He received a scholarship to study at Government College in Kumbakonam, but lost it when he failed his non-mathematical course work. He joined another college to pursue independent mathematical research, working as a clerk in the Accountant-General's office at the Madras Port Trust Office to support himself. In 1912-1913, he sent samples of his theorems to three academics at the University of Cambridge. Only G. H. Hardy recognized the brilliance of his work, subsequently inviting Ramanujan to study under him at Cambridge.

During his short lifetime, Ramanujan independently compiled nearly 3900 results (mostly identities and equations). Although a small number of these results were actually false and some were already known, most of his claims have now been proven correct. He stated results that were both original and highly unconventional, such as the Ramanujan prime and the Ramanujan theta function, and these have inspired a vast amount of further research. However, some of his major discoveries have been rather slow to enter the mathematical mainstream. Recently, Ramanujan's Formulae have found applications in crystallography and string theory. The Ramanujan Journal, an international publication, was launched to publish work in all areas of mathematics influenced by his work.

ARYABHATTA (476 - 550)

Aryabhata was born in Patliputra in Magadha, modern Patna in Bihar. Many are of the view that he was born in the south of India especially Kerala and lived in Magadha at the time of the Gupta rulers; time which is known as the golden age of India. There is no evidence that he was born outside Patliputra and traveled to Magadha, the centre of education and learning for his studies where he even set up a coaching centre. His first name “Arya” is hardly a South Indian name while “Bhatt” (or Bhatta) is a typical North Indian name even found today specially among the “Bania” (or trader) community.

Whatever this origin, it cannot be argued that he lived in Patliputra where he wrote his famous treatise the “Aryabhata-Siddhanta” but more famously the “Aryabhatiya”, the only work to have survived. It contains mathematical and astronomical theories that have been revealed to be quite accurate in modern mathematics. For instance he wrote that if 4 is added to 100 and then multiplied by 8 then added to 62,000 then divided by 20,000 the answer will be equal to the circumference of a circle of diameter twenty thousand. This calculates to 3.1416 close to the actual value Pi (3.14159). But his greatest contribution has to be zero. His other works include algebra, arithmetic, trigonometry, quadratic equations and the sine table.

He already knew that the earth spins on its axis, the earth moves around the sun and the moon rotates round the earth. He talks about the position of the planets in relation to its movement around the sun. He refers to the light of the planets and the moon as reflection from the sun. He goes as far as to explain the eclipse of the moon and the sun, day and night, the contours of the earth, the length of the year exactly as 365 days. He even computed the circumference of the earth as 24835 miles which is close to modern day calculation of 24990 miles.

This remarkable man was a genius and continues to baffle many mathematicians of today. His works was then later adopted by the Greeks and then the Arabs.

DTU HOSTEL FACILITIES

1.0 INTRODUCTION

DTU campus hostel facilities temporarily started with Type - IV flats for boys in 1995 and Type - V for girls in 1996. These facilities were initially created to cater the needs of outside Delhi students as well as the Delhi students staying far off from the college campus. Later Sir C.V. Raman hostel for boys was started in the year 1997 and subsequently Sir M. Visvesvaraya, Sir J.C. Bose, Varahmihira, Bhaskaracharya, Homi Jehangir Bhabha, & Aryabhatt Hostels for boys and Sister Nivedita and Kalpana Chawla Girls hostel for girls were started. The approximate capacity of boys and girls hostel are around 1700. Hostels are provided with facilities of solar water geysers, T.V. with cable connection, Table Tennis, Carom, Chess, Badminton Court, Gymnasium & Reading Room & LAN connection.

ADMINISTRATIVE OVERVIEW

1. DTU boys and girls hostels are meant for full time B.Tech., M.Tech., MBA students.
2. Vice Chancellor will nominate the Chief Warden. He will be assisted by the Wardens of different hostels nominated by him. The Wardens shall look after the general administration/ maintenance and extra-curricular activities of their respective hostels. The Chief Warden may nominate Officer-in-charge /Coordinating Warden/Deputy Chief Warden among one of the Wardens if required for his help for smooth functioning of hostels administration.
3. The policies of the hostel are decided by the Warden Council under the overall guidelines and policies of the University. The decision of the Warden Council of the hostel in the matter of duration of stay, allotment of seats to the residents of different disciplines/ categories, guest status fees and other rules for students, shall be final and binding.
4. The admissions are made as per the rules approved by the Wardens Council of the Hostel.
5. The main hostel office is located at the Ramanujan (Transit Hostel), ground floor room no. 2. The Chief Warden of the hostels manages the Hostel facilities in the campus with the assistance of Warden Council. The Wardens have their offices in their respective hostels.
6. Hostel Application/Registration forms shall be available at our website : hostels.dtu.ac.in
7. The Bulletin of Information containing the rules & regulations will be issued by the hostel office on payment of ₹100/- to all the allottee of the hostels.

2.0 RULES OF ELIGIBILITY OF HOSTEL ALLOTMENT

Hostel allotment will be provided on the basis of the category selected by the candidate during admission at Delhi Technological University. No further changes of category will be allowed.

Hostel allotment is very limited and our priority is to accommodate candidates coming from Outside Delhi Category and so it may be possible that Delhi Category candidates may not get hostel accommodation.

- 2.1 Hostel accommodation is limited and will be allotted to full-time bonafide students of DTU. However, the applicants should satisfy the following eligibility criteria for hostel allotment. After the allotment of the rooms the allottee will be held responsible for any damage in his / her room.

For First year B.Tech students

- a. The first preference for hostel accommodation will be given to Outside Delhi Category students (as per given in admission slip).
- b. All fresh applicants belonging to PH category shall be provided hostel accommodation if they apply for it.
- c. All foreign/ NRIs students will be treated as Outside Delhi Category students.
- d. If seats are available, the second preference for hostel accommodation will be given to those from outside Delhi but studied in Delhi, provided that they produce certificate for their stay in hostels during Senior Secondary schooling (Certificate from Recognized School)
- e. If seats are available, the next preference will be given to Delhi Category students residing more than 35 km. from DTU campus.
- f. Long distance will be priority in allotment to Delhi Category students.

For senior For B.Tech/M.Tech/MBA students

- a. For senior students already living in hostels, accommodation will be provided to the students having no back log & back papers/ merit wise.
- b. All senior students belonging to PH category with back paper will be provided hostel accommodation.
- c. If any seat is still available it will be allotted to senior students on applying fresh.

For First year M.Tech/MBA students

- a. Hostel accommodation will be provided on the basis of distance.
 - b. No accommodation will be provided to sponsored candidates.
- 2.2 Before admission / during period of stay, if the resident is found not fulfilling any of the above conditions, he / she will be required to vacate the hostel immediately.
 - 2.3 Suppression of facts/ furnishing wrong information pertaining to any of these eligibility criteria would lead to cancellation of allotment or suitable disciplinary action will be taken by the hostel authorities.
 - 2.4 In exceptional cases, the hostel allotment criteria may be relaxed as per discretion of competent authority.

3.0 ADMISSION TO HOSTEL

- 3.1 The newly admitted students seeking hostel admission should apply for the fresh hostel allotment online vide hostel website: hostel.dtu.ac.in. Printout of complete Registration Form along with the required documents should be submitted to the hostel office, DTU. Student shall mention his Bank A/c No.in the application.
- 3.2 The senior students already living in hostels seeking hostel admission should also apply for hostel online. Printout of duly filled admission form along with the required documents and receipt of payment of ₹50/- for general candidates and ₹20/- for SC/ST/OBC/PH candidates should be submitted to the hostel office, DTU. The form should also be certified by the concerned hostel Warden.

4.0 CRITERIA FOR RENEWAL OF HOSTEL ADMISSION

All the UG and PG students will be given admissions in the hostel only after registration and as per the eligibility criteria for hostel allotment as mentioned in clause No. 2.0.

UG and PG Students: The renewal application form duly signed by concerned Warden should reach the Hostel Office within stipulated time /date, otherwise the concerned student may not be allotted accommodation for the forthcoming academic year.

5.0 DURATION OF STAY

A student will be eligible to stay in the hostel for duration of his course as given below:

a)	B.Tech.	4 Years
b)	M.Tech./MBA	2 Years

NOTE :

After allotment of the room, a student will report to the attendant of concerned hostel and will take possession of the room after signing inventory of the furniture, electrical, internet port and other items in the room.

All the B.Tech. and MBA hostel residents are required to vacate their allotted rooms within one week of the last examination each year and handover the charge of the room including all items on the inventory to the hostel attendant. The rooms will be reallocated at the beginning of each Academic Session.

The students who are required to stay in the hostel during summer vacations for genuine reasons i.e. summer internship / workshop training etc. will be allowed with the payment of ₹1000/- per month (June/July). Such allotment will be made on case to case basis at the sole discretion of the hostel office, candidate cannot claim for accommodation during this period.

As there is no summer vacations for M.Tech. Students they are allowed to keep their allotted rooms during vacations. However, rooms will be reallocated at the beginning of each Academic Session.

8.0 REFUND OF HOSTEL SECURITY

1. The refund of hostel security will only be made on the personal submission of refund request by the candidate only after the surrender of hostel accommodation and clearance of all other dues alongwith photocopy of cheque of his/her bank account .
2. Those students who wish to withdraw their hostel security after completions of their academic course at DTU, they will have to apply for refund in person alongwith No dues certificate issued by concerned Hostel Warden, otherwise no refund will be initiated.
3. The application for hostel security refund will be considered upto three years only after the last stay of student in hostel failing which hostel security will liable to be forfeited.
4. The amount of security will be refunded through RTGS/NEFT/Bank Transfer only.

9.0 INSTRUCTIONS FOR ALLOTTEE OF DOUBLE / TRIPLE SEATER ROOMS

- 9.1 Allotment of seats in double and triple seater rooms where one resident is already staying shall be prerogative of the hostel authorities. If student is staying alone, one key of the room should be deposited with Hostel Office / Authorities.
- 9.2 The residents who are staying alone must ensure that they are available in the hostel during the days of fresh admissions. If they are not available for more than one week, their rooms will be opened with other key of the room kept with the hostel authorities so that the newly admitted students are accommodated without any problem. In case the residents have to be away for more than a week, they are required to take the inventory of their belongings beforehand, the hostel administration will not be responsible for any loss / damage caused.
- 9.3 In case resident is away or not available for more than 7 days, without leaving the key with hostel authorities , the lock of his room will be broken in presence of representative of student association / residential warden and Care - taker of the hostel. In all such cases, the hostel office/university will not be responsible for any loss / damage caused to the belongings of the resident already staying in the room.
- 9.4 If the first occupant of the double/triple - seater room does not allow the second allottee into the room, it will be deemed as a serious act of indiscipline. The resident who tries not to accommodate a partner in a double - seater room or triple seater room, while being available in the hostel, will be liable to disciplinary action as per the eviction rules.

10.0 CANCELLATION OF HOSTEL ADMISSION

The Hostel authorities are authorised to evict any resident/guest/person from any room of the hostel, if in their opinion, such resident/guest/person violates the discipline or disturbs the peace of the hostel. For the purpose of eviction, authorities will follow a fair procedure. The decision of the Warden Council shall be final in such cases. Hostel allotment will be cancelled and entry restricted in area of hostels, if a resident fails in complying with any one of the following:

- i. Non - payment of dues within the due dates.
- ii. Keeping guests without permission (illegal)
- iii. Indulging in Anti - Social activities in the hostel.
- iv. Mischief causing damage to the hostel property.
- v. Ceases to be a student.
- vi. If students is continuously absent for 7 days without prior permission.
- vii. Any misconduct or misbehaviour with fellow student, faculty, warden, staff or any other persons within DTU or outside.
- viii. Any other complaint received by hostel office.

11.0 SCHEDULE OF PAYMENT FOR MESS CHARGES

1. All first year students including B.Tech/M.Tech/MBA students have to pay mess bill of each semester in advance at the time of admission.
2. All mess dues of students except first year students should be paid by 20th of each month. The fine for the late payment of the mess dues is as follows:
 - i. From 21st of the month to last day of the same month fine @ ₹50/- will be charged in addition to his/her mess dues.
 - ii. For next first month fine @ ₹100/- will be charged including above said amount in addition to his/her mess dues.
 - iii. For second month fine @ ₹200/- will be charged including above said amounts in addition to his/her mess dues.
3. A hosteller who fails to pay his/her dues for more than of 2 month may be asked to vacate the hostel accommodation.
4. The hosteller going on long leave are also requested to pay the fees within the stipulated period either in advance or through on line payment.
5. Mess Advance for two months is adjustable when the student finally leaves the hostel.

12.0 RULES REGARDING THE MESS / DINNING HALL

- 12.1 Hostel Messes are being operated by hostel students council through a mess manager on “No Profit No Loss” basis.
- 12.2 The residents are expected to maintain proper decorum in the Dinning Hall. Shouting and sitting on the mess table is strictly prohibited, if any one is found doing so he/ she shall be fined ₹100 to ₹1000 depending on the severity of offence.
- 12.3 The Mess Secretary from the hostel will normally be elected / nominated and he/ she and his /her team will look after the quality of the food provided and ensure hygiene in the mess.
- 12.4 Food will not be served outside the dining hall for students. However, in case of illness, students may be served “SICK DIET” in their rooms with prior permission of the Warden.
- 12.5 In no case except the case of illness, mess utensils should be taken outside the dining hall.
- 12.6 In no case, a resident can enter the kitchen either to collect food or to communicate any grievances regarding food with kitchen staff.
- 12.7 Wastage of food is strictly prohibited, if any student found to leave the food in his/ her plate, shall be fined suitably.
- 12.8 A resident who desires to entertain authorised guests in the Dining Hall shall purchase requisite number of coupons for the required meal against cash payment in advance.
- 12.9 Mess charges will be reviewed and fixed / changed every six months, preferably in January and August, in consultation with members of the Mess Committee and hostel Wardens.

13.0 MESS REBATE

Mess facility is compulsory for all the hostellers. Any candidate seeking to avail hostel accommodation shall avail to use mess facility. Mess facility is provided as a compulsory part of hostel accommodation to the student so that he/she does not have to worry about quality food timely during their stay at the University in the hostels. It is the philosophy to provide calm and peaceful environment to the students staying at the hostels to focus on their studies and excel in their career. Under no circumstances mess charges will be waived off for any hosteller. Only in exceptional cases of medical emergency and academic compulsions (prior permission) mess rebate can be claimed by the hosteller which shall further be verified and approved by the respective Warden and Hostel Office-in-charge/Chief Warden. If the Warden or Hostel Office-in-charge/Chief Warden does not approve the claimed mess rebate than the issue will be deemed settled and no further claims in this regard will be entertained. If claim of mess rebate is agreed and approved by the Warden/Hostel Office Incharge/Chief Warden than still in such cases 1/3 of the normal monthly mess bill will be charged from the candidate.

14.0 HOSTEL ASSOCIATION

- 14.1 The residents may form a Hostel Association for promoting academic, cultural and recreational activities, in addition to a compulsory mess committee. The Chief Warden/Officer-in-charge (Hostels) / Warden shall have the right to attend or not to attend any meeting of the Association or its bodies.
- 14.2 The Hostel Association shall consist of all bonafide residents of the hostel and will function in accordance with the Hostel Association rules as approved by the University.
- 14.3 The Hostel Residents Association Executive, consisting of a President, a Vice - President, a General Secretary, a Sports Secretary, a Cultural Secretary, and a Mess Committee, consisting of six members shall be duly nominated by the hostel Warden.
- 14.4 The hostel reading room will be available for use by the residents only and will be looked after by the Cultural Secretary under the guidance of the Hostel Warden. The reading room will remain open from 8:00 a.m. to 10:00 p.m.
- 14.5 The cultural secretary will also organize games and other social and cultural activities under the supervision of the hostel authorities.
- 14.6 All the Hostel Association activities will be under the control of Chief Warden/ Officer-in-charge (Hostels) through the hostel Wardens.
- 14.7 The President of Hostel Association will take permission of the Chief Warden/ Officer-in-charge (Hostels)/ Warden for all functions. The Warden, in consultation with the Chief Warden/Officer-in-charge (Hostels), reserves the right to not to allow disallow any activities, which according to the authorities are not conducive of the maintenance of healthy academic environment in the hostel.
- 14.8 All functions of the Association should end normally by 10 p.m. In case the function is likely to be extended beyond that time, prior permission in writing should be obtained from the Chief Warden/ProVC/VC.
- 14.9 The residents are expected to observe the code of conduct and rules of discipline of the hostel approved by the University.
- 14.10 In general, in the interest of the residents, the Association General Secretary, in consultation with the President, can call a General body meeting, which will be presided by President / Vice - President. No person, other than the bonafide resident can be present in the meeting. The outcome of the meeting, in the form of a resolution, should be forwarded to the Chief Warden/Officer-in-charge (Hostels) through the Warden. The Chief Warden/Officer-in-charge (Hostels) may take a decision or place it before a Wardens council depending on the nature of resolution.
- 14.11 The Chief Warden/Officer-in-charge (Hostels) is authorized to call meeting of residents to provide any information and instructions whenever he desires.

15.0 GENERAL RULES AND REGULATIONS FOR HOSTEL RESIDENTS

1. No hostel resident can keep any motorised vehicle in the University. However, bicycles are permitted for local transport. Disciplinary action including fine will be imposed on the defaulters.
2. Ragging is strictly prohibited inside as well as outside the Hostel/ Campus. If anyone is found involved in ragging, he / she may be taken up as per Hon'ble Supreme Court orders. Fresher should promptly report to the Warden or Officer-in-charge (Hostels)/ Chief Warden or any other competent authority if ragged.
3. Any act of intimidation or violence, wilful damage to property or drunken and riotous behaviour constitutes an offence. If anybody is found to do so, he/she shall be liable for expulsion from the Hostel / University.
4. If they found indulged in these activities, they will be expelled from hostel without serving any notice in this regard and disciplinary action shall be taken.
5. Use of narcotics, consumption of alcoholic beverages and gambling are strictly prohibited.
6. Misbehaviour or Indulging in a row with staff members / security staff will be treated as an offence and will be liable for expulsion from the hostel.
7. Hostel inmates shall be required to enter their names into the register before leaving the campus during the weekends and seek written permission from their hostel Wardens before leaving the hostel for a long leave.
8. Boys Hostel inmates shall not be allowed to leave/enter the hostel after 11 p.m. In event of anyone reporting late, necessary disciplinary action will be taken against them.
9. All the hostellers are required to sign their attendance daily on attendance register. The attendance register is available with the Hostel Attendants. If some one fails to sign their attendance consecutively for seven days without permission of their Warden, their accommodation will be cancelled without any notice.
10. All girl hostellers must be back in the hostel by 9.00 p.m., necessary disciplinary action will be taken against the defaulters.
11. No female member is permitted to visit the room of the boys hostel. However, the visitors are permitted to see their wards in the visitors room only.
12. No male member is permitted to visit the girls' hostel. However, with the permission of warden, the visitors are permitted to see their wards in the visitors room only.
13. The students have to seek prior permission of the Chief Warden/Office-in-charge through Warden of their respective hostel alongwith the consent of the student with whom he/she is going to stay in the hostel. They are also required to pay guest charges @ ₹50/- per day in advance under the intimation to hostel office. A student/ guest shall not be permitted to stay for morethan 5 days.
14. Entertaining / providing accommodation to any unauthorised person in the hostel room is punishable. If anyone is found to do so,he/she will be expelled from the hostel.

15. Adherence to the time norms (as mentioned in point no. 8 and 10) will be treated as grave misconduct, which may result in expulsion from the hostel and the decision of the Warden Council will be final and binding in this regard.
16. Outsiders are not allowed in the girls hostels/boys hostels.
17. No day-scholar / any other person is permitted to stay in the hostel after 9:00 p.m., otherwise suitable disciplinary action will be taken. However, if any one wanted to meet students living in hostel should take necessary permission from the warden.
18. The hostel inmates should take care for the safety of their belongings inside the room. The University shall not be responsible for any such losses. Items like jewellery, costly watches and mobile phones must not be kept inside the hostel rooms.
19. Those inmates, who want to use desert cooler during summer in their allotted room, have to seek prior permission from the respective hostel warden and a sum of ₹300/- per semester will be charged. If some one fails to pay the charges as per the notice issued from the hostel office, the residents may be charged from the deadline given in the notice.
20. Display of any type of vulgar posters/calendars inside the allotted rooms is strictly prohibited. Anyone found doing so shall be fined ₹1000/- for subsequent offences and at last expulsion from the hostel.
21. Cooking of food of any sort and keeping any inflammable items inside the hostel is strictly prohibited.
22. All the hostel residents shall abide by the above mentioned Hostel Rules. Any violation of the Hostel Rules will be viewed seriously. The Hostel Wardens are fully empowered to deal with residents in the manner the situation demands.
23. In case of emergency, residents are advised to get in touch with the concerned hostel Warden/ Officer in- Charge (Hostel Office)/Chief Warden.
24. Residents are required to see the Notice Boards for necessary announcements made from time to time. Any suggestion to improve the social, cultural, academic and intellectual environment of the hostel is always welcomed.
25. Notwithstanding, the provisions in previous pages, the Chief Warden is the final authority in matters of discipline, admission and overall functioning of the hostels.
26. The students residing in various hostels are permitted to use electric iron and kettle for their personal use on the payment of ₹100/- per month per item, only after taking prior permission from respective warden. However, use of room heaters and other electrical appliances are not permitted.
27. Minimum duration of stay at the hostels shall not be less than 85% in any case. Attendance shall be reviewed on monthly/semester/yearly basis by the concerned warden and hostel office. Any student found short of attendance or frequent absentee shall be considered unwilling to stay at hostel and his/her allotment shall be cancelled and could further be allotted to needy student.
28. In case of loss of hostel identity card the student will be fined ₹200/- and a copy of FIR is required to issue duplicate hostel identity card to the student.
